## Operational Permits

The California Fire Code was adopted by the City of Hanford Ordinance number ( ) The Hanford Fire Department enforces Fire Code adoptions as it relates to permits to operate Operational Permits. Any property owner, and business owner who conducts certain operations shall file an application with the City of Hanford Fire Department to obtain the required Operational Permit. This permit is an official document, and the Certificate shall be issued by the City of Hanford which authorizes performance and operation of specified activity. Multiple permits for the same location, depending on their use, may be consolidated into a single permit, and each provision is listed on the permit. The permit shall be issued and for paid for when the business license payment is due. The first permit will be included in the new business inspection; any permits required after this point will have a fee attached to said business.
