ANNUAL CONTRACT FOR CHEMICAL SUPPLY SERVICES

The City of Hanford Purchasing Division is soliciting Bids for an annual contract for services to provide weed and pest abatement chemicals, poisons, pesticide handlers training, Certified Pest Control Advisory recommendations, and headquarters inspection for Water Conservation Plant and Public Works Divisions on an as needed basis.

The initial contract shall be for a twelve (12) month period and shall, at the City's option and upon mutually agreeable terms, be renewable annually thereafter for two (2) consecutive one-year periods. Bids are sought from contractors who have a proven record of experience in providing the services required by this Invitation to Bid. The successful bidder shall be responsible for providing all services necessary to fulfill the requirements of this Invitation to Bid upon receipt of the City's Notice to Proceed.

Pre-Bid Teleconference: A non-mandatory, informational pre-bid teleconference has been scheduled for **Wednesday, January 21, 2026 beginning at 10:00 a.m.** To register for the teleconference, please email the attendee's contact information to purchasing@hanfordca.gov and a link to the teleconference will be emailed to you. This meeting is an opportunity for interested proposers to ask questions regarding the project and the Request for Bid requirements.

Local Vendor Preference: In an effort to encourage local businesses to provide goods and services to the City, the Council has enacted a Local Vendor Preference policy. The Local Vendor Preference policy will apply to any business that has a fixed business address within Hanford City limits. A Post Office Box will not be accepted as a business address. The City reserves the right to request proof of the City of Hanford address.

Executive Order N-6-22 – Russia Sanctions: On March 4, 2022, Governor Gavin Newsom issued Executive Order N6-22 (the EO) regarding Economic Sanctions against Russia and Russian entities and individuals. "Economic Sanctions" refers to sanctions imposed by the U.S. government in response to Russia's actions in Ukraine, as well as any sanctions imposed under state law. By submitting a bid or proposal, Contractor represents that it is not a target of Economic Sanctions. Should the State determine Contractor is a target of Economic Sanctions or conducting prohibited transactions with sanctioned individuals or entities, that shall be grounds for rejection of the Contractor's bid/proposal any time prior to contract execution, or, if determined after contract execution, shall be grounds for termination by the State.

The City hereby ensures that Minority Business Enterprises and Disadvantaged Business Enterprises (DBE) will be afforded full opportunity to submit proposed bid in response to this notice. Individuals and entities submitting bids to the City of Hanford will not be discriminated against on the basis of race, religion, color, national origin, ancestry, physical or mental disability, medical condition, genetic status, marital status, gender, gender identity or expression, sexual orientation, military and veteran status in any consideration leading to the award of contract.

No qualified disabled person shall, on the basis of disability, be excluded from participating in, be denied the benefits of, or otherwise be subjected to discrimination under any program or activity leading to the award of a contract.
